COMMENTARY

International Arrivals

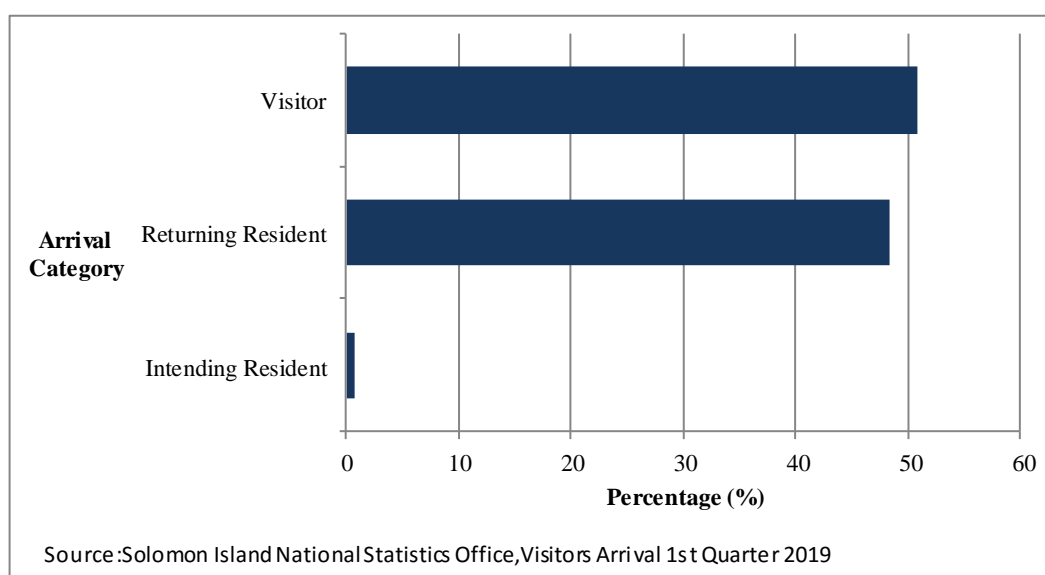
Total arrivals for the first quarter 2019 were 11,849. This is a decrease of 23.0% compared to the previous quarter (4th quarter 2018). Compared to the same quarter a year ago, a decrease of 2.2% was recorded.

Visitors made up 51% of arrivals for first quarter 2019. This was followed by Returning residents with 48% of arrivals and the remaining 1% were Intending residents.

Visitor arrivals for the first quarter decreased by 10.3% to 6,019 visitors, compared to the fourth quarter 2018 figure of 6,711 visitors. There was a 4.4% decrease in visitors arrivals from first quarter 2018 to first quarter 2019.

Chart 1 shows that the returning and visitors categories make up the largest proportions of all arrivals while the intending resident category makes up the lesser share this quarter. This information comes from table 1: Total Arrivals to the Solomon Islands by Purpose of Travel by Sex: 1st Quarter 2015 to 1st Quarter 2019.

Visitors by Country of Residence

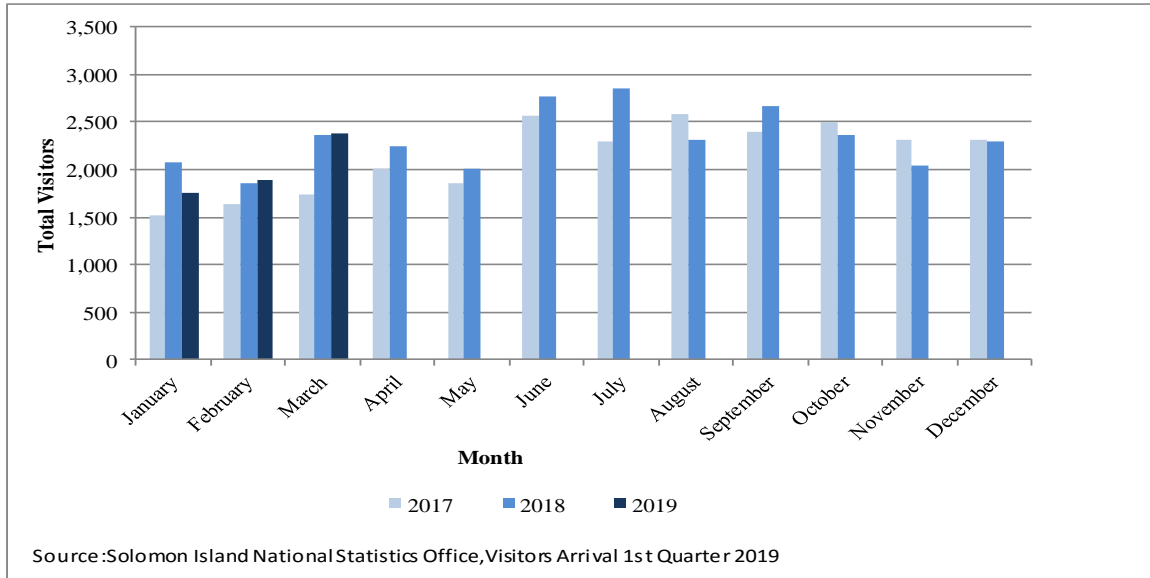
Arrivals by country of residence for the first quarter 2019 showed that Australians (37.9%) remain the largest group of visitors to the Solomon Islands. There was a 14.0% decrease to 2,279 in Australian visitors compared to the fourth quarter of 2018 figure 2,650.

The next largest group of visitors were from Other Asia (12.4%), followed by New Zealand (7.4%), Other Pacific (7.1%), Fiji (6.3%), United States of America (5.8%), and China (5.0%). Table 2 shows detailed information on Visitor Arrivals to the Solomon Islands by Country of Residence: 1st Quarter 2016 to 1st Quarter 2019.

Visitors by Month

Visitor arrivals by month showed that March recorded the highest number of arrivals in the first quarter of 2019 with 2,378 visitors. This was followed by month of February with a total of 1,891 visitors and January the least with 1,750 visitors. This information comes from Table 3: Visitor Arrivals to the Solomon Islands by Month: January 2009 – March 2019.

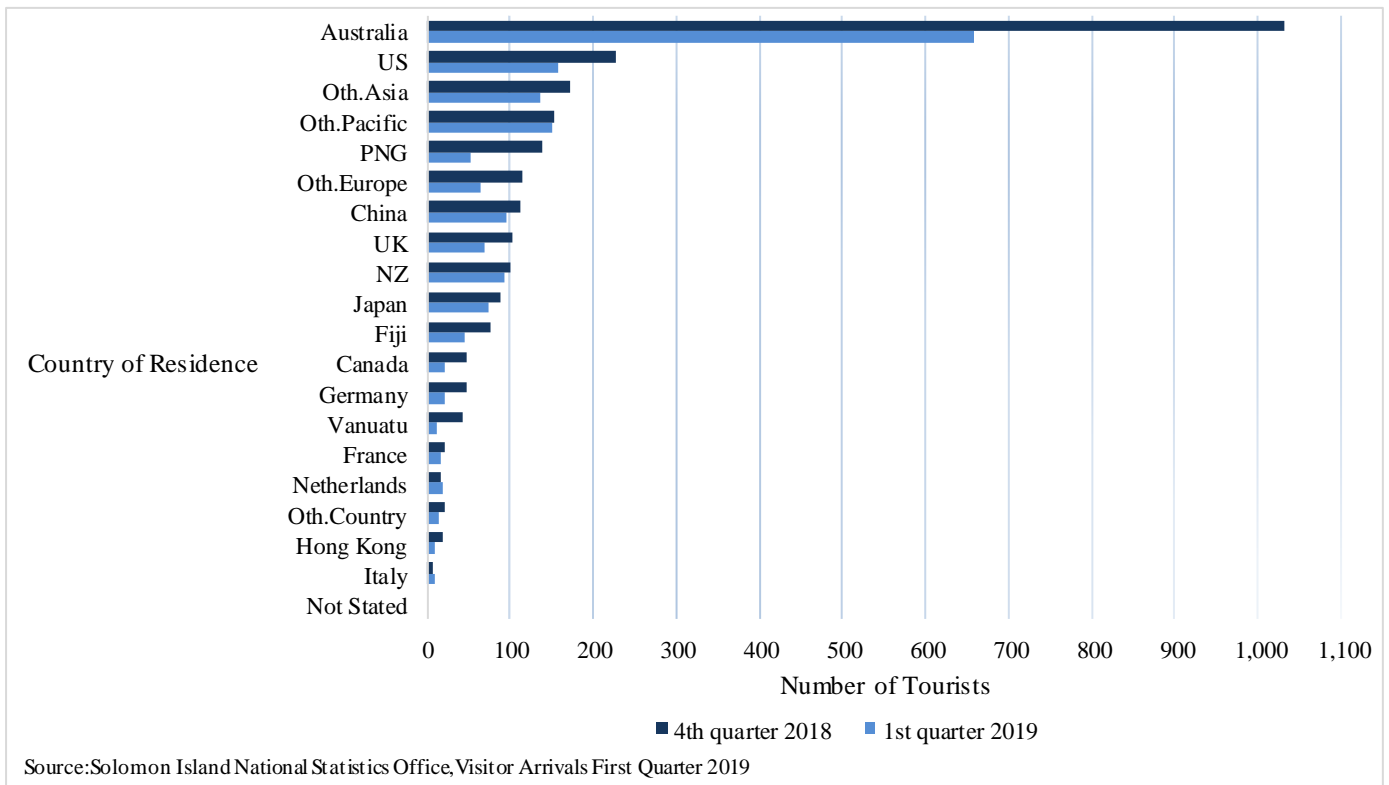
Chart 2: Visitor Arrivals by Month, January 2017 – March 2019



Tourists

First quarter 2019 recorded a total of 1,718 tourists and they spent an average of 14.9 days in the country. Australian residents still made up the highest proportion of tourists (38.3%) for the quarter and stayed in the country for an average of 13 days. Residents from the United States of America made up the next largest group of tourists (9.2%), followed by Other Pacific (8.7%), Other Asia (8.0%) and China (5.5%) Refer to Table 4: Visitors to the Solomon Islands Classified as Tourists by Country of Residence and Average Length of Stay (in days): 1st Quarter 2017 to 1st Quarter 2019.

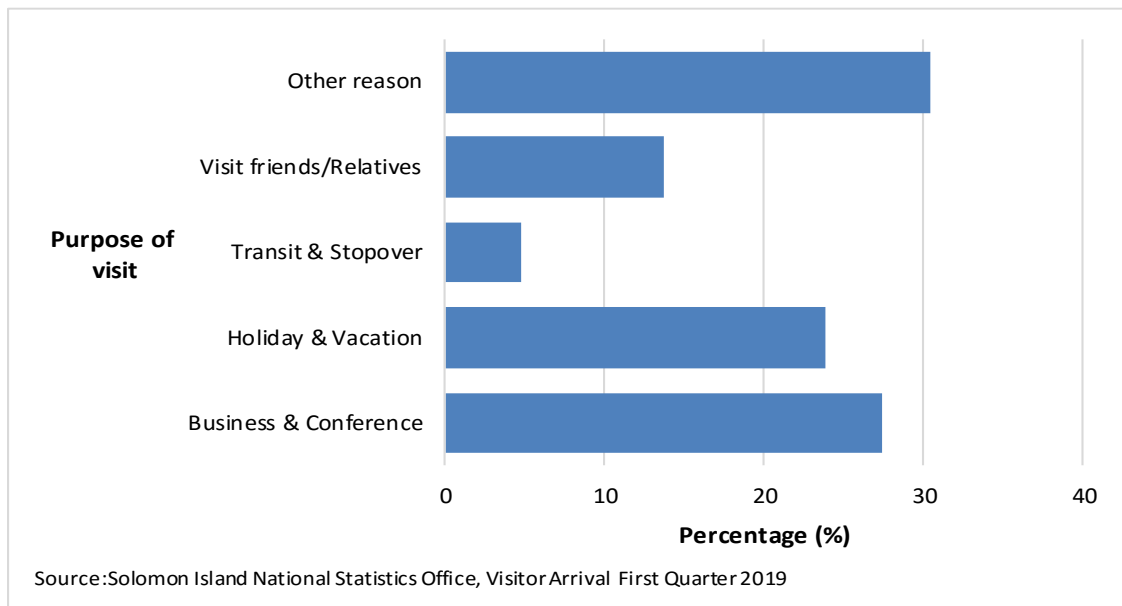
Chart 3: Tourist Arrivals by Country of Residence: 4th Quarter 2018 – 1st Quarter 2019



Visitors by Purpose of Visit

The most common reason for visitors visiting the Solomon Islands during the quarter was for Other reason (30.4%). This was followed by Business and Conference (27.4%), visiting for Holiday and vacation (23.8%), Visiting friends and relatives (13.6%) and Transit & Stop over (4.8%). Visitors by Age Group

The distribution of visitor arrivals by broad age groups for first quarter 2019 showed that 77.3% of Visitors were in the 25 years to 64 years age range. The youngest age group, 0 -24 years, represented 11.0% of the arrivals while the oldest age group, 65 years and over made up 7.9% of total visitor arrivals. The remaining 3.8% were visitors who did not state their age. Male visitors represented more than half of the total visitors arrivals (72.3%) and female visitors made up 27.7% of arrivals this quarter. Visitors by Occupation

Visitor by Occupation showed that the “Other occupation” category makes up the largest percentage of occupations (42.7%) during the quarter. This was followed by “Professional and Technical” (25.6%), No work (9.6%), Administration and managerial position (9.2%), and Service worker (5.9%). Visitor by Carrier

The most popular carriers during the quarter were Solomon Airlines who carried (44.2%) of total visitors, followed by Air Niugini (25.3%) and Virgin Australia (14.7%).

ABOUT THE BULLETIN

Concepts and Definitions

Persons entering Solomon Islands classify themselves into three (3) categories; returning resident, intending resident, and visitor. The concepts and definitions of the various categories are as follows:

(i) Returning residents

- Solomon Islanders and non-Solomon Islanders who have left the country and are returning to continue their residence.
- Non Solomon Islanders includes resident permit holders and Diplomatic officials, and their immediate family members. This may also includes legal or official arrangements that fall outside of the above.

(ii) Intending residents

- Non-Solomon Islander who wish to take up residence in Solomon Islands.

(iii) Visitors

- Any traveller who is not a Solomon Islander and their stay and intention of stay should last no more than 12 months¹, in the country and does not have a permanent/contract employment.
- *Tourist*
 - Visitors who further classify themselves stating their visit are purposely for '*holiday and vacation*'. This exclude, tourist arrivals by cruise ships.
 - Wife accompanying husband on business purpose is a private tourist unless also working.
 - World Tourism Organization WTO definition of Tourism:
It comprises the activities of persons travelling to and staying in places outside their usual environment for not more than one consecutive year for leisure, business and other purposes not related to the exercise of an activity remunerated from within the place visited.

(iv) Markets

- Country of Usual Residence is referred to as 'markets' by the Solomon Islands Visitors Bureau

Note: For Quarter 1 2018 onwards the National Statistics Office will be using the new set of definitions provided by the South Pacific Tourism Organization (SPTO).
