# SICCI renews MoU with RSIPF

oyal Solomon Islands Police Force (RSIPF) and SICCI recognises that there is a definite link between the rule of law in a nation and growth in investment which underpins private sector development and job creation.

This was reiterated on Thursday 19 August 2021 during the re-signing of the Memorandum of Understanding (MoU) between SICCI and the RSIPF after a review on the MoU was conducted.

Representing the RSIPF was Police Commissioner, Mr. Mostyn Mangau and SICCI Board Chairman, Mr. Ricky Fuo'o as the signatories to the MoU.

An initial MoU was signed in 2018 after both parties agreed to enter into a

MoU in relation to a partnership and joint agreement with the objective to strengthen the relationship between the RSIPF and SICCI.

The purpose of the MoU is to provide a platform for cooperation between the RSIPF and SICCI to:

- · Promote crime prevention initiatives;
- Recognise the commercial perspective of businesses within the community;
- Recognise both the RSIPF and SICCI share a social conscience for community wellbeing;
- Allow for the sharing and exchange of information on areas of mutual interest;

- Build a strong relationship that will contribute to nation building, stability, employment opportunities and economic growth; and
- Facilitate two-way communication for the Parties.

SICCI Chairman, Mr. Fuo'o said the importance of the MoU resigning cannot be overstated, especially in these unprecedent times of pandemic and economy uncertainty.

He said the relationship between the RSIPF and SICCI might be seen as unusual in other settings or time but the Chamber sees this as an important link between two frontline communities, the law enforcement and business community.

"In 2018 when we reached out to RSIPF it was a milestone that we have agreed on the signing of MoU to work together to cooperate and promote a secure, peaceful and safe environment in which communities and businesses can prosper through increased economic activity and security," he said.

"The re-signing of the MoU highlights a significant step in our commitments to create an enabled environment for businesses to thrive in a safe, secure and peaceful environment. The understanding also signifies a growth in our relationship

and understanding that the most effective approach is to reach out and grow close with our communities," Mr. Fuo'o added.

Police Commissioner, Mr. Mangau acknowledged the renewal of the MoU as a step forward in terms of the partnership between the RSIPF and SICCI and an opportunity for increase capability and responsiveness as it gives strength to crime prevention strategies.

"We have managed to achieve some of our targets under the previous MoU and the RSIPF under my leadership looks forward for further working together with SICCI to progress our ongoing and future plans.

"We can work together to create opportunities that benefits young people. Our renewed partnership offers the chance for young people not only to reconnect with their family and community life, but to have access to support and opportunities to find employment and meaningful pathways in life through the support of SICCI and your membership," he said.

The Police Commissioner also acknowledge the role of the private sector in keeping the country's economy afloat during these difficult times.

An Executive Group was established under

the MoU that enabled meetings and dialogues to take place with exchange of updates between RSIPF and SICCI on identified common priorities where both parties can work together to promote a safe and stable investment climate in the Solomon Islands.

Some of the priorities under this MoU were Road and Traffic issues, Security, Crimes Prevention and updates on recently the COVID19 efforts by the RSIPF at the borders.

SICCI Chief Executive Officer (CEO), Ms. Natalina Hong says: "We believe that the

relationship between public and private sector is a crucial partnership, which if strengthen we can adequately face the challenges ahead such a fast-growing population, high unemployment, rapid urbanisation, corruption and inequality."

SICCI believes that it is only though partnership, collaboration, co-ordination that we can collectively set the course to achieve our collective version of a better, safer and more secure future.

On behalf of its members, SICCI would like to thank the RSIPF and look forward to work together between both parties.

# SICCI urges eligible members to get vaccinated

SICCI is urging members, their employees and eligible members of the general public to be vaccinated to protect them from the COVID-19 virus as soon as possible.

SICCI acknowledges that vaccination is the most effective and efficient means in which we can protect ourselves and our country against the deadly virus as waiting for a community transmission will already be too late.

"As a Chamber, we commend Government through the Ministry of Health and Medical Services for rolling out the country's vaccination program in Honiara, Guadalcanal, Choiseul and Western Provinces including Malaita Outer Islands," Chief Executive Officer (CEO), Ms Natalina Hong, said.

"However, we share the same concern on

the slow uptake of COVID-19 vaccination in the country to a level that would protect our population from COVID-19 in the event the virus breaches our borders and reach our communities," she added.

The SICCI Secretariat and Board have been vaccinated since the vaccine became available and we urge member businesses that interact with the public to do likewise.

"Vaccination is one of the main ways to protect our communities and businesses to reduce the possibility of community spread if and when our borders are reopened," Ms Hong said.

"SICCI supports Government's cautious approach to date, but with efforts to keep the country's economy afloat at this difficult time we cannot afford to keep our borders closed forever and isolate

ourselves from the rest of the world. With the stringent measures taken many member businesses are struggling to survive especially those in the tourism sector," the SICCI CEO said.

Unless a significant number of the targeted population receives the vaccine, it will be difficult for Government to make a decision on opening our borders, as such, the Chamber urges all eligible residents where the vaccination program is been rolled out who have no underlying medical conditions to take the vaccine so we can get our economy back on track.

"The real impact on individual businesses, their owners, the people they employ, and their families who depend on them will be severe and felt for many months to come if we have community transmission in our communities."

ICCI believes the country can maximise the benefits of infrastructure spending if there are policies and regulations in place to promote local content.

SICCI Board Chairman, Mr. Ricky Fuo'o said focusing on maximizing local content ensures that local workers have a job that will lead to skills development and transfer

Not only that but local suppliers will also have an opportunity to grow in the market, and local companies will develop and contribute to revenue that remains in the country and promotes the standards of local private sector, he said.

Mr. Fuo'o was speaking the Prime Minister's Breakfast on Friday 21st May hosted by SICCI for its members to have an opportunity to directly engage with the country's leadership.

"It is vital that Government takes an active approach to ensuring the greatest benefits from infrastructure development are retained locally. Procurement processes should prioritize local business and MSMEs.

"Some countries prioritise local

business in their tenders under a certain monetary threshold. Likewise local partnering and minimum local employee requirements can be a requirement for contracts given to foreign businesses," he said.

SICCI believes that creating such regulations and policies to promote local content will maximise local participation, otherwise local businesses will remain spectators in all these infrastructure developments.

SICCI further acknowledges the actions taken by the Government to stimulate economic activity and improve productivity through infrastructure spending and to development partners

who have contributed towards these infrastructure developments.

Some of these multi-billion dollars infrastructure activities have already been committed to and are currently being constructed. These includes the 2023 South Pacific Games projects, Tina River Hydro Development Project, Upgrade - Munda International Airport Project, Tar Seal of Seghe and Taro domestic airport, Henderson International Airport Upgrade, Fisheries-

Henderson road, White River Highway-road and the USP Campus project.

"Infrastructure is often considered to provide a 'double befit' to the economy. Initially short-term as an economic stimulus and then in the long term, from benefits the new infrastructure provides. Social and economical infrastructure is essential to sustainable economic growth and poverty alleviation," SICCI Chair, Mr. Fuo'o, said.

Meanwhile, SICCI will also continue

to advocate for fundamental reforms especially in Transport and Tax which are pivotal to expansion of businesses.

These will require partnership, consistent dialogues and support to ensure there is a fair and level playing field for all.

# SICCI encourages local content in big infrastructure spend

SICCI encourages the Government and relevant authorities to ensure there is sufficient local content included in the billion-dollar worth of infrastructure projects that are planned for the next five years to enable the economic benefit to remain inside Solomon Islands.

SICCI Chairman Mr. Ricky Fuo'o highlighted this when SICCI representatives appeared before the Public Accounts Committee (PAC) recently during the inquiries into the 2021 Appropriation Bill 2021.

Considering the number of foreigners currently competing across certain industries in Solomon Islands, one of the things SICCI is advocating on is for Government to focus on local content.

"That is to formulate some form of threshold, where certain number of contracts are reserved for indigenous businesses and individuals. This can be done not only for the construction industry but also for suppliers and across all industries," Mr. Fuo'o, said.



The SICCI Chair said this is purposely to protect our local industries, businesses and local jobs.

"For most indigenous businesses and existing businesses, all the money we make and spend stays in the country. If we continue to promote local content and protect local businesses that would have a big impact on economic growth as well," he told members of the PAC.

"Local competition is growing and international competitions are coming in but there is no form of protection for local industries and indigenous business owners," he added.

Solomon Islands has a large pipeline of infrastructure projects that is about to be spent into our economy which the Chamber considers as being a key factor in the country's economic recovery.

"One other thing we have been advocating for on a lot of these large international contracts is to see local content built into it.

"So that a certain percent of that work is down streamed to local contractors,

local suppliers and local businesses.

"While we have these big expenditures of infrastructure, there is that spill over effect into the local economy, to ensure we are not just by-standers when a lot of these infrastructure are getting built and delivered," Mr. Fuo'o said.

SICCI also understands that there are currently around SBD7.5 billion worth of infrastructure projects that are either underway or tabled for the next four (4) to five (5) years.

These projects including Solomon Water Capital Works (SBD 760M), Tina River Hydropower (SBD 1.95bn), ADB Ports and Road program (SBD 1.115bn), Kukum Highway Phase II (SBD 256M), World Bank Roads and Aviation Project (SBD 451M).

There are also the bilateral agreements with Development partners such as the sport stadium and construction work proposed for the 2023 Pacific Games which total to an approximate SBD2.5bn.

# Express Freight launches 'Less Than a Container Load' service at BA5 event

xpress Freight Management (EFM), with support from Strongim Bisnis, have invested in the creation of a scheduled less than container load service. With this service local exporters can ship as little as 1m3 and only pay for that amount, instead of the whole container.

This new service was launched during the SICCI Business After 5 (BA5) networking event on Friday 6 August at the Heritage Park Hotel.

EFM Country Manager, Mr. Ronnie Isip says at the moment they are focusing on exporting agricultural products to the global market as a way of providing assistance to local agricultural farmers.

"At Express Freight we are aware of the requirements and needs of the people and through our services we will give time to consolidate those products, put them in a container and then send them globally opening the market for Solomon Islanders," he said.

According to Mr. Tim Lawther, Business Partnership Director at Strongim Bisnis, Sectors cannot grow unless they can trial new products and/or new markets.

Mr. Lawther said Express Freight have proven to be a collaborative and reliable partner to Strongim Bisnis in this initiative.

"Strongim Bisnis will guarantee the empty space under 13m3, which is roughly the break-even point to send a container.

"This means if only 6m3 of space is bought by an exporter, we (Strongim Bisnis) will cover the remaining 7m3. If 11m3 is bought, we'll cover 2m3," he said.

He said, as long as at least 1m3 is booked, Strongim Bisnis will cover 12m3 and the container will go every two months for a start, to Singapore, and from there anywhere in the world.

"If this is successful, we may guarantee the Less Than Container Load (LCL) services with greater regularity to other locations. And with other freighting firms.

With this LCL service Strongim Bisnis will also be collaborating with the Pacific Horticultural and Agricultural Market Access Program (PHAMA Plus) and Mr. James Kana from Ueniusu'unu Agribusiness Group who have launched an LCL Platform, to allow businesses to book consignments online and with ease. The two interventions will fit together and give exporters options.

"I think it's going to be transformative for any Solomon Islands business requiring outbound freight," Mr. Lawther said.



# Pasifiki HR's disabilities database for employment

ICCI acknowledges one of its members, Pasifiki HR for a new service they have introduced which will provide employment support for people living with disabilities.

This new service was recently launched during SICCI's latest Business After 5 (BA5) networking event on Friday 6 August, 2021.

"Basically, what this new service involves is that we work with training institutions that train people living with disability and disability organisations to source people with skills," Pasifiki HR's People Manager, Alphea H Tufah, said.

"We will have this database that we are going to register them on and then we will work with employers on giving them work experience," she added. "If any employer is interested in employing them then we are happy to support them in that aspect as well."

"We look forward to having more employers come forward and support our people who are living with disabilities," Mrs. Tufah said.

People living with disabilities make up 10% of the country's population that is being excluded from economic activities.

Mr. Tim Lawther, Business Partnership Director at Strongim Bisnis, said to quantify the issue in Solomon Islands, the skills, talents and efforts of in excess

of 50,000 people are not being utilised.

He said Strongim Bisnis will share in the risk of this new venture for both Pasifiki HR and the employers who engage them.

Strongim Bisnis will be offering subsidies to employers who take on employees (people living with disabilities), as well as tied grants for workplace accessibility modifications. Pasifiki HR will be building a database of jobseekers with disability, including their specific skills – presenting a strong pool from which employers can draw.

# SICCI welcomes reduction in electricity rates

he Solomon Islands Chamber of Commerce and Industry (SICCI) is understandably heartened by the news that electricity tariff rates are going to be reduced starting in May 2021.

SICCI, as the peak body representing private sector in the country, welcomes the decision by the Government to revise the current Electricity Tariff Regulations as timely and relevant for the long-term economic recovery ahead.

From discussions with the Solomon Power CEO, SICCI understands that the reduction will be made to non-fuel Tariff which is the cost other than fuel



to produce and deliver electricity to homes or businesses, including the cost to operate equipment and maintain facilities.

Fuel Tariff (the cost for fuel required to provide each kilowatt-hour (kWh) of electricity) is not subsidised unlike other regions and therefore will still remain.

SICCI has been a strong advocate for a reduction of tariffs which was included

in its submissions to Government for the Economic Stimulus Package and more recently in the Private Sector Pathway to COVID-19 Recovery Strategy.

"Reducing the tariffs will also reduce the immediate burden placed on households and would provide immediate relief for businesses at a time when cash-flow is decreasing alarmingly," SICCI Chairman, Mr. Ricky Fuo'o, said.

s an organization that strives to achieve excellence in corporate governance, the Solomon Islands Chamber of Commerce and Industry (SICCI) is again delivering the Essential to Directorship Programme.

The four-day programme got started at the Heritage Park in Honiara on Tuesday 27 April with twenty-five participants from various sectors including senior representatives from State-Owned Enterprises (SOEs), the private sector and the public sector.

SICCI has been delivering the Essential to Directorship Programme since 2018 in partnership with the Institute of Directors, New Zealand (IODNZ).

Two programmes were delivered in 2018 and one in 2019. The 4th Directorship Programme was initially planned for 2020, however, due to the COVID-19 global pandemic it was delayed until this month and for the first time this year's programme is delivered online.

This programme offers a comprehensive



introduction to boardroom governance. It exposes participants to international best-practice in developing organisational strategy, oversight of finance, managing risk and assessing performance.

Delivering his remarks at opening day

on Tuesday 27th April, SICCI Chairman, Ricky Fuo'o said the benefits of the Directorship Programme will go beyond governance skill building.

"It is beneficial to our personal growth

and confidence, developing strong leadership, decision making ability in the boardroom and way to add value to our respective organisations," the SICCI Chairman told participants.

The purpose of the program is to develop governance. Participants will gain an awareness of the responsibilities and challenges of being in a governance role. Together we will examine the opportunities for participants to support effective governance and how to influence relationships, create an environment based on trust and respect and build individual's leadership capability.

Mr. Fuo'o acknowledged the significance of the governance training, noting that strategic clarity at the Board level can go a long way in influencing positive change at the operational level.

"Governance plays an essential role in defining leadership and management practices that ensure long-term success.

"A high-performing board can make all the difference when it comes to long-term corporate success - and implementing best corporate governance practices is a key board responsibility," he said.

He said such training can no longer be considered for big companies and organizations only and insisted that providing executive education and relevant board of directors training programs, must be integrated in all companies, churches, civil society and government agencies to increase performance.

Chief Executive Officer (CEO), Ms. Natalina Hong said the Chamber is committed to improving Boards and company-owning structures through this programme.'

"There continues to be a need to train up more individuals in this area, as it means that there will be more diversity in the domestic pool to draw Board Directors, and CEOs from.

"At the moment, this pool is very limited. Also, the training method of learning from curated examples, such as discussions around case-studies and sharing of international best-practice is ideal, as it will improve decision making process and leadership within the country's boardrooms," she said.

At the end of this year's offering, this represents 100 Directors, CEOs and Senior Managers having been educated

in international best practice Board governance.

Mr. Fuo'o said SICCI's continuous emphasis on partnership with Government and development partners is crucial for growing business that will impact economic growth. # "Fundamental Reforms needed to create better

# business environment"

ICCI and the Economics Association of Solomon Islands (EASI) has highlighted to the Solomon Islands Government (SIG) a number of fundamental reforms priorities that would create a better business environment.

This was during a SICCI-SIG Consultation on earlier this year focusing on Government's Policy Redirection which is aimed at cushioning the negative economic impact of COVID-19.

"As a Chamber, we would want to see some tangible actions in regards to Government's reform priorities.

"If resources are limited within Government to undertake some of these legislative reforms than we should focus on the few things that we really can achieve," a SICCI statement said.

From a private sector perspective, a comprehensive tax reform – to create and deliver a fair, simple and broad-based tax system is one that is long overdue and requires tangible action.

This could have a big impact on the economy, on private sector and economic recovery.

"Reforming the tax system will be an important driver to improving the business environment settings and

stimulating private sector growth and we are encouraged to hear that the Governments redirection policy aims to refocus and address key priorities within the current policy mandate.

"The current tax structure in Solomon Islands constrains economic growth and limits the pace of development. It imposes a very high tax burden when compared to other Pacific countries and the structure of the tax system is outdated, inefficient, complex, expensive to administer and anti-competitive.

"The tax system imposes high compliance costs on taxpayers and encourages unproductive tax avoidance and evasion activities. Moreover, it does not actively support growth - for example, it does not systematically support exports and instead relies upon distortionary exemptions for exporting industries," the SICCI statement said.

SICCI further highlights that access to finance is also a key constraint to businesses particularly Small Medium Enterprises (SMEs).

According to a World Bank report on SME Finance, it is the second most cited obstacle facing SMEs to grow their businesses in emerging markets and developing countries.

"There is a strong link between access to finance and business growth, and, in turn, growth in employment and incomes. DBSI provides an opportunity for more innovative financing options that are more suited to the Pacific to driver economic diversity and sectors with future growth potential," the SICCI statement added.

SICCI also reiterated that the cost of electricity is also a key cost faced by businesses.

"Solomon Islands faces some of the highest electricity costs in the Pacific and there needs to be a review of the Solomon Power tariff.

"While a thorough review of the tariff model should occur, continued reductions in the tariff will continue to alleviate the costs faced by business and consumers."

These fundamental reform areas highlighted here including other key areas on (1) The basics right to create certainty for businesses; (2) Providing Immediate support to alleviate pressure on business and (3) Actions to stimulate economic activity and improve productivity via infrastructure and sector support are been documented in what will be SICCI's "Private Sector Pathway to Covid-19 Recovery Strategy".

#### **SICCI Sub-committees**

SICCI's subcommittees are now currently underway after full membership have been endorsed following expression of interests from members. The two subcommittees are the Building and Construction and the Manufacturing Industry Working Groups. Both subcommittees have had their first meetings convened in early July 2021.

The subcommittees were established in 2020 by the former SICCI Board with the intent of gathering expert knowledge in the Building/Construction and Manufacturing Sectors to inform SICCI's advocacy efforts to the government.

## **Advisory Group Meetings**

SICCI have had its 2nd Advisory Group meeting on 9th of June, 2021. This is the 12th Advisory Group meeting since the first SIG-SICCI MOU was signed in 2017. It was re-signed last year 2020 to continue this formal link with the Solomon Islands Government. Key areas highlighted during the meeting by the private sector were:

#### RSIPF-SICCI MoU Resigned

Some of the priorities under this MoU were Road and Traffic issues, Security, Crimes Prevention and updates on recently the Corona virus efforts by the RSIPF at the borders.

# EIDO reaches out to Cocoa and Copra producers in Makira

Our Export Industry Development Officer (EIDO), Mr. Ronnie Golopitu was in Kirakira recently as part of a delegation from SICCI, the Pacific Horticultural and Agricultural Market Access Program (PHAMA) and Commodities Export Marketing Authority (CEMA) to conduct a five-day Cocoa and Copra Processing Quality Assurance and Marketing training for rural farmers in the province.

Mr. Golopitu said participants at the workshop were encouraged to be more organised and think Agribusiness as the way forward.

"It is part of SICCI'S strategy to provide relevant trainings, networking and information sharing delivery for its members and potential members especially SMEs to help them grow businesses in a more sustainable way.

"Establishing a Chamber base in the provinces is one other way to achieve a vibrant private sector in the provincial level," he said.

### SICCI partners with PHAMA Plus, CEMA to deliver training for farmers in Makira

Twenty (20) rural farmers and entrepreneurs in Makira/Ulawa Province are now equipped with the relevant knowledge to produce good and quality Copra and Cocoa to meet requirement needed in exporting their products.

This was following a Cocoa and Copra Processing Quality Assurance and Marketing training conducted in the provincial capital Kirakira from 10th – 13 May 2021.

The training was funded by the Pacific Horticultural and Agricultural Market Access Program (PHAMA), coordinated by the Export Industry Development Department of the Solomon Islands Chamber of Commerce and Industry (SICCI) and facilitated by Commodities Export Marketing Authority (CEMA). It targeted those involved in the export supply chain of Cocoa and Copra to

ensure consistent supply of quantity and quality production is achieved.

The training also covered the preparatory tasks farmers should be aware of in preparation for the implementation of the Registration of Cocoa Processing Facilities which includes drying facilities, fermenting boxes and storage sheds as stated in the CEMA Act 2013.

This is also in line with the Ministry of Agriculture and Livestock's 10-year Strategic Plan detailing all processing facilities to be registered so that good quality copra and cocoa can be effectively monitored, tracked and traced back to its original processing facilities while ensuring the quality of copra and cocoa production supply in the Solomon Islands.

SICCI'S Export Industry Development Officer (EIDO), Mr. Ronnie Golopitu said the Cocoa and Copra Processing Quality Assurance and Marketing training was the first of its kind to be jointly conducted with the aim of providing basic information on the practices of producing and processing good quality and marketing of cocoa beans and copra to those in the supply end.
