# Government commended for Tax Review

Tuesday 5 September 2017

The Solomon Islands Chamber of Commerce & Industry (SICCI) has commended the Solomon Islands Government for commencing work to undertake a tax review consultation that involves a wide scope of stakeholders including private sector groups.

SICCI as the peak body representing the private sector has always advocated for tax reform and the review is a step in the right direction.

"Our tax system is too reliant on a single commodity and imposes high tax burden on businesses and individuals, thereby restrictive growth prospects for individuals and the economy," says SICCI CEO Dennis Meone.

"The review is welcoming and would pave the direction for changes to the tax system."

SICCI welcomes the appointment of a Tax Review Consultative Committee (TRCC) and the inclusion of the private sector, statutory bodies and Civil Society Organization (CSO) and other interest groups in the consultative committee.

SICCI Chair, Jay Bartlett commends the government for its vision and for being inclusive in its approach.

"The involvement of the private sector and other stakeholders reinforces the willingness of the government through the Ministry of Finance to collaborate with important stakeholders in working together and explore policy solutions that are tailored to our context," says Mr Bartlett.

According to a Tax Review discussion paper by MoFT, the current tax structure in Solomon Islands constrains economic growth and limits the pace of development.

"The current tax system imposes a very high tax burden when compared to other Pacific countries (with tax revenue accounting for 32 per cent of GDP in 2016) and the structure of the tax system is outdated, inefficient, complex, expensive to administer and anti-competitive.

"The tax system imposes high compliance costs on taxpayers and encourages unproductive tax avoidance and evasion activities.

"Moreover, it does not actively support growth - for example, it does not systematically support exports and instead relies upon distortionary exemptions for exporting industries."

A comprehensive tax review will examine problems with the current system and seek solutions to deliver a tax system that will promote economic growth.

"This will be a fair, simple and broad-based tax system, which ensures everyone who is liable to pay tax, pays the correct amount," says the report.

The tax review will be undertaken in a staged approach over three years.

Stage 1: Review of Tax Administration Arrangements and Consumption Taxes

Stage 2: Review of Income Tax

Stage 3: Other Taxes

The varying sectors involved would be subjected to consult and forward their proposal to the Tax Review committee who can submit recommendations directly MoFT.

SICCI will hold its consultation with the business community this Thursday 7th September at the Heritage Park Hotel.

## SICCI congratulates Solomon Airlines new Tarawa-Honiara-Brisbane route

The Solomon Islands Chamber of Commerce & Industry (SICCI) congratulates Solomon Airlines for establishing its newest flight route to Kiribati, marking the start of a weekly flight plan between

Honiara, Brisbane and Tarawa.

Solomon Airlines made its inaugural flight to Tarawa today. To mark the occasion, the flight carried a small delegation from Kiribati who arrived prior, Government officials from the tourism

sector, private sector representatives and executives of the flag carrier.

SICCI Chair Jay Bartlett, who was among the travelling delegates, said the establishment of the Tarawa route is a historic milestone for Solomon Airlines and will have a diverse impact on both the private sector and the country's tourism sector - serving as a gateway to Australia and Kiribati.

"The Chamber on behalf of the private sector congratulates the achievement of Solomon Airlines and looks forward to its ongoing schedule," said Mr Bartlett.

The Brisbane-Honiara-Tarawa link was signed by Solomon Airlines and Air Kiribati in March this year.

The partnership is followed up from an Air Service Agreement (ASA) and a Memorandum of Understanding (MOU) signed between the Solomon Islands Government and the Republic of Kiribati in November 2016.

It is understood that under this ASA, Solomon Airlines and Air Kiribati, in collaboration with each country's Civil Aviation Authorities, will promote the aviation sector, as well as initiatives stimulating both countries' social and economic development.

# Sumitomo withdrawal a setback to the industry

Monday 14 August 2017

The Solomon Islands Chamber of Commerce & Industry (SICCI) has expressed regret over the withdrawal of Japanese nickel mining giant Sumitomo Metal Mining, and called for improvement to the regulatory policies for incoming investors and businesses.

SICCI Chair Jay Bartlett said it is unfortunate and regretful for a major international investor such as SMM to leave the Solomon Islands after spending most of its time and resources in the courts.

Mr Bartlett stressed the importance of a transparent legislative and regulatory framework for all investors and business to avoid another loss of a potential contributor to the economy.

Retaining Foreign Direct Investment (FDI) is just as important, if not more important, than attracting FDI, he added.

He said SMM's withdrawal is a huge loss for the country especially at a critical time when we need to broaden our narrow economic base and look at alternative growth in other sectors to replace the logging sector. Unfortunately, unclear regulatory systems are disincentives for prospective investments and the departure of SMM is a classic example for us to learn from.

"What message does the closure bring to potential investors? The Chamber views Sumitomo's withdrawal a loss and an opportunity missed for the economy," said the Chair.

"This has cost potentially hundreds of jobs for many Solomon Islanders and the loss of benefits for resource owners."

Mr Bartlett said furthermore many local businesses and service providers are

going to be affected.

The Chamber acknowledges SMM's decision to leave based on the plunge of bauxite pricing, however, also noting the implications of the 6 years long legal battle for nickel mining rights at Isabel Province.

SICCI is concerned and pleads to relevant government authorities to ensure internal regulatory systems are robust, credible and encourages FDI inflows.

## SICCI and MWYCFA signs Grant Agreement to establish Young Entrepreneurs Council

Monday 21 August 2017

A Young Entrepreneurs Council (YEC) will soon be set up under the auspice of the Solomon Islands Chamber of Commerce and Industry (SICCI) after the signing of a Grant Agreement between SICCI and the Ministry of Women, Youth, Children and Family Affairs (MWYCFA) on Monday 22nd August at the Heritage Park.

The agreement was signed by SICCI Chair, Jay Bartlett and the Permanent Secretary (Supervising) of MWYCFA, Justus Denni.

The ceremony was attended by senior government officials, members of the SICCI Board and successful young entrepreneurs.

Through the Grant Agreement, MWYCFA will provide funds amounting to \$200,000 to meet the cost of setting up the council.

SICCI will also provide additional resources including support services.

In his official remarks, SICCI Chair Mr Bartlett commended the leadership and commitment of the Government

through MWYCFA for having foresight to collaborate and invest in a Young Entrepreneurs Council through the provision of funds for its establishment.

The Chair also highlighted the importance of the council: "The Young Entrepreneurs Council will provide a platform for our young and talented youth and aspiring young leaders to access services to transform innovative ideas into successful business opportunities".

"In looking forward to the future, it is vital that young people be part of that

vision and YEC is one of many ways we can engage our young people," says Mr Bartlett.

The Supervising Permanent Secretary of MWYCFA, Justus Denni who signs on behalf of the Ministry also acknowledged the importance of YEC especially in the context of the emerging issues and challenges young people are faced with, noting that YEC will play a critical role in supporting talented entrepreneurs becoming successful.

According to SICCI CEO, Dennis Meone, the signing of the grant agreement continues to demonstrate the true spirit of collaboration between government and the private sector.

"We can achieve so much if we work in partnership and explore innovative ways and the signing is a first step towards operationalizing the Young Entrepreneurs Council," says Meone.

YEC is expected to be formally launched late in the year and will be a representative body and voice for young entrepreneurs including providing support services such as business mentoring, coaching and trainings.



# GPPOL, KPSI and Chamber holds field

The Guadalcanal Plains Palm Oil Limited (GPPOL) with the Solomon Islands Chamber of Commerce & Industry (SICCI) and Kokonut Pacific Solomon Islands (KPSI), will host a field trip today in efforts to boost up the fight against the alarming spread of the Coconut Rhinoceros Beetle.

Stakeholders from the government and different sectors will join a tour at GPPOL'S Ngalimbiu Plantation and KPSI's operations at Henderson in a first-hand demonstration of the damaging effects of the Rhinoceros Beetle.

The tour will include delegates and representatives from businesses, government, donor partners and civil society

organizations. The purpose of the industry led initiative is to raise the profile of the current and potential impact of the Coconut Rhinoceros Beetle on the Oil Palm and Coconut Industries.

The field day will also provide an avenue for the dissemination of accurate information through the media to the public regarding this pest, including

making a united stand for collaborative action to combat the beetle.

Agriculture is considered the backbone of the country's export revenue with almost 40,000 metric tonnes of palm oil valued at SBD\$250 million exported by GPPOL in 2016. Similarly, in 2016 Solomon Islands exported 16,057 metric tonnes of copra valued at SBD\$88 million.

"These two export industries are massive contributors to our economy and with the threat of the beetle the future of these industries hangs in the balance" said SICCI CEO Dennis Meone.

"Eighty percent of the rural people who are directly involved in coconut production will be affected, their livelihood will be affected so as their economic contribution."

"Imagine the effects it will have on farmers, families and communities that depend on coconut and palm oil to meet their basic needs and livelihood" the CEO added.

The Rhinoceros Beetle has spread as far as GPPOL in North East Guadalcanal, North West Guadalcanal, Malaita and Central Islands.

The beetle is a growing threat to the Coconut and Oil palm industry and has the potential to destroy and seriously hinder both industries if no action is taken.

Imagine your business as a tree.

The weather/ climate in which the tree grows is our business environment.

The birds that nest in the tree are our customers.

Flowers and fruits that grow on the tree are our products and services.

The leaves represent our brand, our reputation and our presentation.

The branches reach out to customers – they are our selling mechanisms.

The trunk is the business owner.

Compost which is essential to help the tree grow represents all the resources we need – people, equipment, buildings, money etc.

The roots are our planning, our systems and processes

Seeds are our new ideas

The Earth is our market

The other trees around us are our competitors and or our collaborators

Finally, we need to be mindful of risks – fire and insects can destroy any tree!

During this new series of articles Chris Elphick looks at all the essential elements of successful businesses.

When you have read this article take some time out to look at your business using the tree as a model to help you.

Take a large sheet of paper and draw

a tree – use lots of colour and be creative! Start to identify the different elements as listed above and then for each element ask yourself the following questions:

What do we know about this element? What do we do well? What do we not do so well? What would we like to do in the future?

Make a note of your responses. This is one way of doing a complete review of your business. By using big images like the tree you can involve others – partners, family, staff, customers, suppliers – have fun and collect as many views as you can – write them all down then take a step back and reflect on your business. How strong is your tree? Are there any weak areas? What risks do you have to think about? Are you a tree standing on its own or are you part of a strong forest of protection?

This series will focus on each element of the business tree in turn and will provide you with useful tips on how to ensure your tree is as strong as it can possibly be.

# Our journey to improve the business environment - TAX

Dear Members,

Greetings from the Advocacy Desk. I trust you are well. Since the last update, there were some key development that have taken place.

## TAX

### Tax Reform Review

SICCI has two representatives in the Tax Reform Committee. The government, as you might know, is undergoing a Tax Reform Review. Early in September, the Tax Reform Review was launched. SICCI also has conducted a consultation session with its members to get their inputs and feedbacks concerning tax. In addition to this, the Advocacy Department had accepted a number of feedback emails concerning tax issues and recommendations concerning the Tax Review.

## PAYE

As you already know, one of the 2017 Advocacy priorities is the Pay As You Earn Tax. The Advocacy Department had conducted a first survey. From the data collected a First-pass-analysis was done in collaboration with EASI members. Based on two options, the results indicate the following:

### Option 1: Reduce the PAYE tax bracket rates

By reducing the tax brackets for each income range, disposable income will increase. Analysis from data you have provided us shows that a 1% increase in disposable income will result in 2.3% increase in government revenue paid in other taxes. Or a 10% increase in disposable income will induce a 23% increase in government revenue. It implies that if disposable income increases, government revenue will increase more than two times the increase in the former.

### Option 2: Increase threshold of disposable income from \$15,080 to SBD\$30,000

Increasing the threshold to \$30,000



will benefit low income earners, which means taxing income AFTER \$30, 000.

Our analyses based on data supplied by members revealed that if the income threshold is raised to \$30,000 for an individual tax payer, government revenue will increase to around \$18,849 (through other taxes) per year, assuming all else equal. Based on the NPF data, there are roughly about 55,000 active employees in the country. Taking that into consideration, the government is estimated to collect around \$1,036,695,000 (i.e. 18,849 x 55,000) in a year. This is about 50 percent higher than what is currently collected.

### **PLP Private Sector Scan for Solomon Islands**

The Advocacy Department is working closely with Pacific Leadership Program to facilitate a Private Sector Scan

for Solomon Islands. Two researchers (external and internal) will be doing the scan. Members are contacted and informed on dates which they will be able to meet with the researchers for the consultations. We aim to start the consultations by 9th October 2017.

## Taiwan

### Taiwan Tour for Fu Tsu Construction Company

In August, the Advocacy Officer took a delegation from Taiwan Fu Tsu Construction Company to meet with some of our members. Their purpose was to look for suppliers, builders, architects, consultants to assist them in the construction of the National Stadium in preparation for the South Pacific Games 2023 hosted by the Solomon Islands.
