Thursday 11 April, Honiara – Solomon Island Chamber of Commerce and Industry (SICCI) acknowledges the Australian Government for their continuous support towards the private sector in the country.

SICCI Board Chairman, Jay Bartlett made the acknowledgement after signing a SICCI grant funding agreement with the Australian Government through the Australian High Commission office in Honiara.

The new SICCI grant funding worth SBD5million translates to three years worth of SICCI activities and support for core costs including some staff key positions to progress its private sector advocacy agenda.

"On behalf of the SICCI Board and our members I would like to thank the Australian Government, not only for your continuous support towards the Chamber but also your valuable support to other partners and organizations that promote growth in Solomon Islands' economy and facilitate an enabling environment for investment," Mr Bartlett said.

"The SICCI Board acknowledges the Australian Government's preparedness to work with us to build our representative role for private sector. With previous funding signed in 2016, the Chamber convened events and meetings that

provided networking and learning opportunities for members, and at the same time gave us opportunities to canvass members' views to develop collective private sector positions."

With the first Australian Government grant SICCI developed higher quality policy dialogue with the Solomon Islands Government on the state of the economy and domestic business environment. SICCI worked hard in broadening its membership to capture the range of industries as well as small to medium sized businesses. The tranches were utilized for core funding towards strengthening the secretariat and for activities related to the Chamber's advocacy agenda.

"The growth of SICCI membership to 250 member entities including over 30 province-based businesses resulted in both the increase in SICCI influence and convening power, as well as allowing a fuller national picture on issues businesses are facing.

"This growth aligns with my vision of seeing the Chamber become a true representative organisation for national development which was my platform at the March AGM which saw my election

into the SICCI Board. I am excited to be able to contribute to this important mission as part of the 2019-2020 Board," Mr Fuoo said.

SICCI Chief Executive Officer (CEO), Ms Atenasi Ata noted SICCI projects of gender equality and of development of entrepreneurship that were also implemented in the timeframe of the Australian Government grant agreement.

"It makes sense that building young people as entrepreneurs and improving women's experiences in the private sector were two parallel SICCI efforts as the longer-term cumulative impact on social and economic outcomes leads to a higher chance of realising our goal of a vibrant private sector that delivers jobs and economic growth in the country."

Ms Ata said that this new funding will be used along with raised membership subscriptions and sponsorship packages to implement priorities identified in the new SICCI Strategic Plan 2019-2023.

"SICCI priorities in the new strategic plan were largely informed by the Private Sector Scan (2017) which collated business concerns," she said.

"For the next five years, SICCI will continue

its efforts to remove barriers to growth and improve the business environment. And at the same time, we will deliver events that facilitate cross-learning, conduct trainings that build and improve the capacity of businesses to achieve their full potential.

"The new SICCI strategic plan, therefore, takes a long-term view of business-enabling concerns.

"Also, SICCI has come a long way in building itself as an organisation. There will be continued improvements to financial and human resource

management of the Secretariat, as well as the attraction and retention of high-calibre individuals to deliver on the SICCI mandate," he said.

SICCI Chair Mr Bartlett maintained that SICCI will carry out its policy engagement efforts consistently.

SICCI calls for good governance in mining sector

Friday 8 March, Honiara – SICCI believes that principles of good governance need to be adequately applied in the country's mining sector with mechanisms that are sufficiently established.

The Chamber made this stand following the oil spill disaster in Rennell Island in February caused by the grounded MV Solomon Trader.

The ship was there to load bauxite.

"Government must ensure accountability and good governance practices are observed in the extractive industries especially Mining," SICCI Board Chairman Jay Bartlett said.

"With good governance mining, forestry and fisheries will benefit all Solomon Islanders through tax revenue, through infrastructure development, through employment and through benefits to resource owners.

"These industries must bring a better standard of living for our people and not simply extract our resources with little return," he added.

Meanwhile, SICCI CEO, Ms Ata said Solomon Islands as a country should seriously implement its national mining policy to provide an overarching guide for mineral development.

Ms Ata said the formal mining policy should provide a framework that points the mining industry in the direction the country chooses to proceed.

"Genuine mining companies and foreign

investors can seek such guidance so that they can know clearly the boundaries encompassing the sector and can demonstrate that they adhere to official policy," she said.

She said while mining offers opportunities for economic development, without adequate management, it also poses direct threats to livelihoods, culture, social well-being and our environment.

SICCI understands that the Solomon Islands Government launched its National Minerals Policy in 2017 that ensures resource owners have more say in development of their mineral resources.

Ms Ata said provincial governments should also have more of a role to play under the National Minerals Policy 2017-2021.

She said it is encouraging to note that the policy offers resource owners a direct voice in the industry, whereas previously they could only participate through signing of surface access agreements. SICCI, Mr Bartlett added: "All investors need to be considerate about how they conduct business in our country that is still aspiring to develop. There is an unwritten social licence to respect our democracy, our laws, our people and most importantly our land."

Report on Employer Capacity Strengthening & Project Consultation Workshop Trip

I was invited by SICCI to attend an ILO workshop at the Tanoa International Hotel, Nadi Fiji from 24th to 26th of April, 2019.

On the 23rd, the Solomon Islands delegation met with the ILO ACT/EMP Employer specialist and ILO Legal advisor. We discussed issues that are of immediate concern to Employers in the Solomon Islands. I raised the Minimum wage and the need to review our labor and industrial laws. During the discussion I invited the ILO reps to visit and meet stakeholders in the country so they can formulate projects to assist us.

Workshop was conducted by ILO ACT/EMP together with ILO Suva office.

Attended by employer reps from Fiji, Kiribati, Samoa, Solomon Islands, Tonga, Vanuatu, PIPSO.

The workshop was on Employer's Capacity Strengthening & Project Consultation. Project; Increased capacities of employers and workers organisations to participate effectively in the development of social and labor policy; aims to support employer and worker organisations participate/ contribute to national SDG processes. Project will be implemented in Vanuatu, Kiribati, Fiji, and Samoa and shared (??) to other Pacific Islands countries.

The project four focus areas;

- Build capacities for bi-partite and tripartite dialogue
- Enhance information/knowledge bases and platforms
- Facilitate MSMEs (particularly Young Entrepreneur) prepare for and respond to climate change
- Share information across the Pacific region

The project writes up is completed. Written in New York, full of legal jargons, a bit hard to understand

(requested to put in layman English). Workshop was to improve on the methodology of the project, identify project activities that are relevant to our region, prioritize according to importance and urgency to ensure effective implementation. Basically to develop a clear road map aligned to the project objectives. The output of the workshop will be featured in the project activities which will be distributed later to member countries.

The workshop also discussed some of the challenges faced by businesses in the region. Discussion focused on Insurance so can have a document submitted to the upcoming FEMM meeting for ministers to deliberate on. Some of the

issues highlighted were High cost of insurance, Limited coverage, Lack of micro insurance, Lack of awareness on insurance coverage, Lack of climate insurance, and Lack of conflict insurance.

I was also invited to take part in a plenary session about 'Strategies for building stronger employer

representation' which I discussed SICCI Strategic Plan 2019 2023 KRA of Advocacy, Membership Services, Organisational Strength.

Recommendation

The project activities focus a lot on bi-partite and tri-partite dialogue. There is a need to identify 'fit and

proper' stakeholders, employers and workers organisations that will take part in the dialogue. This project potentially will provide a platform where employers and workers organizations may find common ground for meaningful dialogue which is a rarity. We are currently struggling with the tri-partite dialogue on minimum wage where there's lack of commitment. Our labor and industrial related laws are outdated. This project road map when completed would provide an educated approach for its effective review and reform. Would have been a good project for the Solomon Islands.

The Chamber sees this development as an important realisation of one of its advocacy goals of developing new sectors such as tourism in the country.

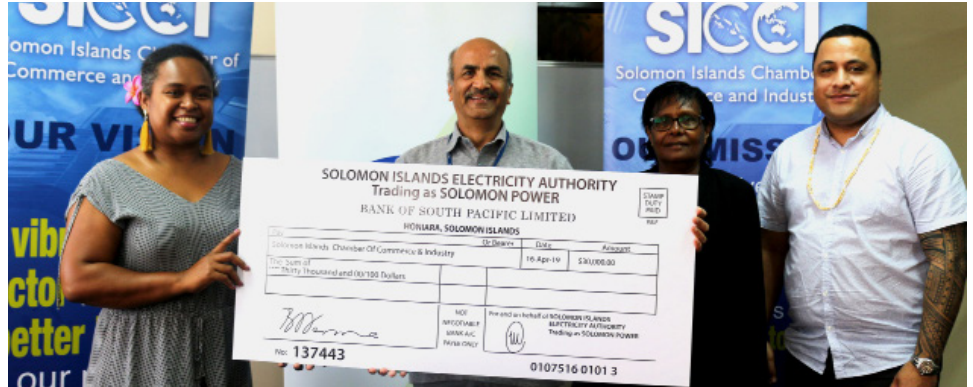

Local basket maker eyes overseas market

One of the key objectives of the Solomon Islands Chamber of Commerce and Industry (SICCI) is to build and improve the capacity and ability of local businesses to achieve their full potential in business, and therefore in contributing to growing the economy.

To achieve this, the Chamber works with Government partners, interest groups and organizations both national and regionally to work through challenges local businesses face.

One such partnership SICCI has utilized is with the Pacific Trade Invest (PTI) New Zealand.

Over the past three (3) years SICCI has been facilitating the participation

of locally owned businesses in the PTI New Zealand annual 'Path to Market' programme which is a multi-stage activity also known as the Pacific Path to Market business capability building programme.

One part of the activity, is where New Zealand businesses are brought into direct contact with Pacific businesses and their products, giving the former an opportunity to meet the people behind these businesses, and the latter a taste of the New Zealand market and to personally explore and potentially establish deals.

This year five local Solomon Islands businesses travelled to New Zealand from 6-10 April.

One of them was Charlie Sango from

Bethlehem village in Central Kwara'ae, Malaita Province.

For Mr Sango, this was a rare opportunity he says would not have been possible if he hadn't decided to fill in the membership form and become a SICCI member last year, 2018.

In New Zealand, Mr Sango showcased a range of traditional handmade cane baskets, locally known as loyacane woven handicrafts.

"For small businesses like mine opportunities such as this are very rare, even more because when we are based in the rural areas," he said.

"That is why I really appreciate the Chamber of Commerce, and for me, their Export Industry Development Department who helped me, enabling me to show case my products overseas," a satisfied Mr Sango, said upon his return from New Zealand on Thursday (11 April 2019).

Basket weaving has been a family business started by his father, and Mr Sango has been involved in what he does for 21 years now.

Most of that time, the products were sold at the community level, which Mr Sango says was just enough to meet the needs of his family and other commitments.

About five years ago he decided to commercial the idea into a business, and started selling the baskets in Auki, occasionally travelling to the capital Honiara to sell his products.

Today, Mr Sango is the proud owner of RLO Bethlehem Handy Craft, a financial member of the Chamber of Commerce.

"It's a family business that initially started with my nuclear family," he reiterated.

The impact from his small business has reached outside of his immediate family however, with other villages who have begun basket-making apart from his own community.

"It has a bigger impact on our livelihood. It helps us in terms of paying school fees and building good houses for our families," he said.

Mr Sango learnt about the work the Chamber of Commerce does in representing small businesses during his visit to a SICCI stall set up during the Police Open Day in Rove, West Honiara in September 2018.

Mr Sango was at the Police Open Day to sell his baskets to members of the public attending the event where he found himself talking to SICCI's Export Industry Development Officer (EIDO), John Paul Alasia and Media and Communications Officer, Philip Lilomo who had explained the work of

the Chamber, and some of the goals in supporting business it was established to deliver.

He also heard about the practical benefits of becoming a member of the Chamber.

A week later, Mr Sango showed up at the SICCI office the Hyundai Mall in central Honiara to complete formalities and become a member.

He was invited as a member of the Chamber, to attend the PTI NZ Path to Market workshop which was run on 18 October last year in Honiara.

The one-day workshop was part of the PTI New Zealand multi-stage programme, aimed at selecting local businesses to participate in a subsequent trade mission to New Zealand.

Although Mr Sango is not currently exporting internationally, he says recent sales in Honiara were about 100-150 baskets.

He went to New Zealand therefore, with the hope to find markets for his products there.

And participating in the Path to Market programme from the 5th-10th April in New Zealand has given Mr Sango the opportunity to explore this market for his products.

China's biggest online market, Alibaba.com who had sent representatives to the Path to Market, met with Mr Sango, and they expressed keen interest in Mr Sango's homemade loyacane baskets.

"That was the whole aim of going to New Zealand for this programme and I'm really encouraged by the fact

overseas buyers are showing interest in my work.

"I will also follow up on this online marketing offer because what I want in the near future is to start sending my products overseas," Mr Sango said.

SICCI's EIDO Officer, John Paul Alasia, led the Solomon Islands delegation to New Zealand.

He also commended the five local businesses who showcased their products at the Path to the Pacific Trade Show at The Cloud, the Auckland-based venue.

"This was a great opportunity for our local businesses to test market their products and learn from their experience in New Zealand.

"The capacity-building opportunities such as learning how to better market products through developing values-based pitches, this helped the businesses identify for themselves how to make their products even more attractive.

"Being able to directly interact with the public and potential buyers at the Path to Pacific Trade Show was another positive feature of the programme," Mr Alasia said.

PTI NZ has had more than 300 companies in the region go through the Path to Market programme over the past 4 years.

The 7-stage programme starts with an in-country workshop. Potential exporters are identified and invited to attend the Auckland part of the programme that includes a showcase event. This year, that showcase event was the Path to the Pacific Trade Show at The Cloud on April 6.

Domestic and Sexual Violence to People and Business

Honiara, March 26, 2019 -A new study shows employees in Solomon Islands lose more than two working weeks a year due to domestic and sexual violence, with one in three employees experiencing violence in the past 12 months.

The study, of more than 1,200 employees working for companies in Solomon Islands, was undertaken by IFC, the International Finance Corporation, with the Solomon Islands Chamber of Commerce and Industry, SICCI. It's part of their joint work on the Waka Mere Commitment to Action, under which 15 companies in Solomon Islands, have committed to promoting gender equality in the workplace.

Surveying employees at nine businesses in the country, the study shows almost half the employees surveyed had experienced some form of domestic and sexual violence in their lifetime, with a quarter saying violence occurred at least once a month.

The study shows that stress and physical effects of domestic and sexual violence follows people to work. More than 80 percent of people who'd experienced violence reported at least one negative impact on their work, most often making it difficult to get to work, stay at work or impacting how they felt at work. These impacts included feeling anxious,

depressed or ashamed at work, and feeling unsafe.

The study shows that although men and women are both affected, more women experience violence and report slightly more effects. Overall, 49 percent of women and 38 percent of men reported they had experienced violence in their lifetime. The study also shows responding to the effects of violence also takes up staff time, with an average of five and a half days a year spent discussing the issue, helping someone access services or addressing the

impact of absenteeism, lateness or low productivity.

Alasia and was accompanied by five (5) SME's.

The objective of the trade mission is to for small local businesses in the area of agribusiness, handicrafts, jewelry, clothing and food from the Pacific to test market their product in a New Zealand market.

SICCI commends RSIPF's response to Honiara disturbance

Sunday 28 April, Honiara – The Solomon Islands Chamber of Commerce and Industry (SICCI) commends the professionalism and capability shown by officers of the Royal Solomon Islands Police Force (RSIPF) and the Correctional Services in dealing with the violent unrest experienced in Honiara City following the Prime Minister's election on Wednesday 24th April, 2019.

SICCI, on behalf of its members and the business community, thank the hard work of the RSIPF officers who risked their own safety to maintain law and order in the capital.

SICCI particularly commended the RSIPF's Police Response Team (PRT) who were able to contain the situation on Wednesday avoiding further looting and damages to businesses and properties.

"From our observations, we are impressed by the conduct of RSIPF and we call on our members and the general public to show support to the force on the streets and their executive in dealing with the situation," SICCI Chief Executive Officer (CEO), Ms Atenasi Ata, said.

"The Police work as seen these past days was one of utmost professionalism and endurance," she added.

Ms Ata welcomes the assurance by the Police Commissioner that normalcy is back and pleas to individuals wishing to continue with more violence to think twice for the sake of peace in our capital and continuous growth of our country.

"Events like Wednesday's opportunistic violence can have significant negative impacts on business activities as we have witnessed, so as a Chamber, we strongly condemn the disturbances that has occurred.

"The resulting damages can set businesses back in having to rebuild and restock. The costs in non-operating days also impact on the everyday Solomon Islander. In most cases the customer at the end of the chain will meet these costs," Ms Ata said.

SICCI also calls on Solomon Islanders to accept the outcome of the Prime Minister's election and allow issues that came up to be dealt with accordingly through the right processes.

"At the end of the day there is a process for electing a country's political leaders. So, we are all encouraged as individuals to engage in those channels.

"It must also be kept in mind that laws and policies that impact on things like jobs for young people pushed out of the education system are captured in platforms of the Government of the day," SICCI CEO, Ms Ata, said.

Therefore, the Chamber remains a ready and willing partner to develop the strategies concerning industry-growth and job creation.

"By doing this we can address the observation that the majority of the crowd causing the unrest were young unemployed men and boys," Ms Ata said.

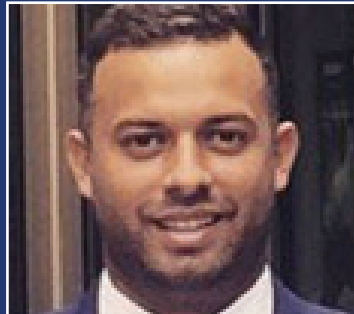

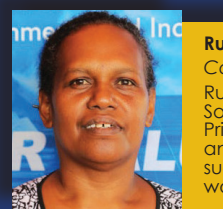


John Wopereis
