SICCI calls on MID to convene Road Transport Board

Wednesday 24 July, Honiara - SICCI has called on Government through the Ministry of Infrastructure and Development (MID) to convene the Road Transport Board (RTB).

The RTB has not been activated since its establishment in 2009.

SICCI firmly believes that its convening will ensure that traffic rules are enforced.

SICCI Board Member and Honiara businessman, Sir Bruce Saunders says until the RTB is formed and operating, the Royal Solomon Islands Police Force (RSIPF) has no power in imposing penalties when taking control of the traffic management in the City.

One practical way this can be done would be in imposing penalties in managing traffic in Honiara City.

The RTB was set up by the 2009 Traffic Amendment Act. This Act placed responsibility for the licensing and regulation of road transport, and the enforcement of traffic regulations with the



RTB.

The Board itself will consist of a mix of Government representatives, RSIPF and key stakeholders including the Permanent Secretary of MID as the

SICCI Board Member and Honiara businessman, Sir Bruce Saunders highlighting the need for MID to activate the Road Transport Board (RTB) during a stakeholders forum on infrastructure priorities for private sector hosted by SICCI in Honiara in August. Sir Bruce believes that unless the RTB is formed and operating, Police has no power in imposing penalties when taking control of the traffic management in the City.

Chairperson, Clerk of the Honiara City Council (HCC), the Commissioner of Police (or the Commissioner's nominee),

the Permanent Secretary of the Ministry of Provincial Government (or the PS's nominee), the Permanent Secretary of the Ministry of Commerce (or the PS's nominee), the Chief Mechanical Engineer of MID, a representative of the Chamber of Commerce (SICCI) and a representative each from taxi and bus operators.

SICCI CEO, Ms Atenasi Ata says the RTB will ensure functions and powers under the Traffic Act 2009 are well coordinated, administered and enforced.

"The RTB will allow for proper administration and better enforcement of our traffic laws, which could then include on-the-spot fines, appointment of enforcement officers and undertaking of prosecutions in the Magistrates' Courts by officers of the Board for minor offences," the SICCI CEO said.

According to the Act, the functions of the RTB are (a) to formulate, implement, monitor and review policies in relation to road transport, in conjunction with the functions of the Ministry to formulate nation transport policy; (b) to coordinate the implementation, administration and enforcement of this Act; (c) to prepare and submit quarterly reports to the Minister on the implementation, administration and enforcement of this Act; (d) to submit to the Minister any information in relation to this Act, if so required by the Minister; and (e) other functions given to it under this Act or any other written law.

The objective of the Act can be achieved by the activation of the RTB.

The RTB is responsible for carrying out the functions and powers under the Act for the registration and licensing of motor vehicles and licensing of drivers, including Convening the Road Transport Board will be a significant step towards driving improvements to traffic congestion in Honiara which will impact productivity for private sector.

formulation of road transport policies for consideration by Government.

It also has the power to institute and conduct prosecutions for offences under this Act, its regulations or Highway Code, subject to any written directions by the Director of Public Prosecutions, and to exercise any other powers conferred on it under this Act or any other written law.

Therefore, SICCI appeals to the Permanent Secretary of MID and Chairman of the RTB to call for the first properly-constituted meeting of the Board.

Under a MoU SICCI and the RSIPF signed in 2018, an Executive Working Group was established and one of the issues discussed was the traffic congestion usually experienced at the Fishing village market.

SICCI representatives on this issue - Sir Bruce Saunders and Mr Toata Molea - are actively involved in a Traffic Working Committee comprising of RSIPF and SICCI representatives formed to find solutions to the issue.

They both agree that it is common knowledge that adhoc parking at the Fishing village market is the cause of the congestion.

"But without the RTB, Police does not have the authority to give infringement notices and enforce them. Only the RTB can have this power as stipulated in the Traffic (Amendment) Act," says Sir Bruce. SICCI Advocacy Officer, John Kanai Ta'amora said better improved flowing of traffic supports daily business activity and indicates a fast-growing economy.

Mr Ta'amora cautioned that the combination of continued economic growth and an increasing population means that congestion in Honiara is only going to get worse if not managed properly and in a well-coordinated manner.

"I believe that convening the Road Transport Board (RTB) will be a significant step towards driving improvements to traffic congestion in Honiara which will not only impact productivity for private sector but will also ensure that public servants get to work on time which in turn will positively improve the performance of our public service and our students will be able to arrive in schools on time," Mr Ta'amora further added.

Key research that supports this call by SICCI was one done by the Economics Association of Solomon Islands (EASI) in 2017.

The research found that the cost of the amount of time spent sitting in traffic due to congestion instead of working productively in the office is SBD3.7 million each year.

SICCI welcomes commencement of undersea cable

Tuesday i6 July, Honiara – SICCI welcomes the much-awaited laying of the fibre optic cable between Honiara and Sydney, Australia as part of the Coral Sea Cable System which commenced in Honiara over the weekend.

SICCI, as the peak body representing private sector in the Solomon Islands, eagerly looks forward to the completion of this national project and the positive impacts it will have on private sector and community.

Chair of SICCI, Mr Jeremy Bartlett reiterated that the Coral Sea Cable System project has a huge potential to drive economic development for the Solomon Islands.

"Faster, affordable and reliable internet services in the Solomon Islands among others is a pre-condition to creating an enabling environment for business and investment and will have a positive cross cutting flow on effect.

"Among many benefits, the cable will boost the county's internet speed connection, and for the average Solomon Islander, it should translate to cheaper communication rates. We are excited with its potential to enable innovations in systems and processes both for Government as well as for businesses. It could result in better and more efficient ways of doing business and most importantly, help bridge the gap between private sector and public sector," Mr Bartlett said.

The SICCI Chair acknowledges the Government for placing this project as a national development priority as part of its commitment to deliver tremendous social and economic benefits to the Solomon Islands people through the availability of fast reliable and costeffective telecommunications services.

Mr Bartlett also thanked chiefs and tribal representatives in Guadalcanal Province for partnering with Government and calls for their continuous support which will enable all Solomon Islanders to benefit from this is national project.

The Coral Sea Cable System is a 4,700km long fibre optic submarine cable system linking Sydney, Australia, to Port Moresby, Papua New Guinea and Honiara, Solomon Islands. The project also includes a 730km submarine cable system connecting Honiara to Auki (Malaita Island), Noro (New Georgia Island) and Taro Island.

Australia will provide the majority funding for this cable, with PNG and Solomon Islands Governments jointly contributing up to one third of project costs.

The Coral Sea Cable System and the Solomon Islands Domestic Network are on track to be ready for service by December 2019.

Waka Mere trains women to drive

Thursday 4 July, Honiara – 12 women including employees from two State-Owned Enterprises (SOEs) who are participating in the Waka Mere Commitment to Action initiative have successfully completed an intensive six-week driver training and are now certified drivers.

Wednesday 28 August, Honiara – The Solomon Islands Chamber of Commerce and Industry (SICCI) hosted its annual Small Medium Enterprise (SME) training workshop from 26-27 August 2019 for small businesses in and around Honiara.

The two-day training event was planned to help these businesses in practical and growth-oriented ways.

The seventeen (17) participants benefited from sessions like 'Hiring that first worker'; 'Developing a business web presence'; 'Cyber security for businesses' and 'Accessing SME-specific Finance'.

The training workshop was supported by Solomon Telekom Ltd and Solomon Post.

Small businesses are the backbone of the Solomon Islands economy as they provide services and goods or products all over the country and provide much needed employment.

These businesses make up close to 70% of SICCI's membership.

SICCI's Membership and Services Officer, Ms Naomi Mara says efforts to build required infrastructure, ensuring good governance and providing social welfare for our citizens should be accompanied by strengthening of SMEs.

"SMEs can contribute significantly to

UNDP encourages private sector, businesses to implement CSR

Monday 22 July, Honiara – The United Nations Development Programme (UNDP) in the Solomon Islands is encouraging private companies in Solomon Islands to publish sustainability reports and are urging entrepreneurs to implement Corporate Social Responsibility activities relevant to the Sustainable Development Goals (SDGs).

This was reiterated during a Solomon Islands Chamber of Commerce and Industry (SICCI) Business After Five (BA5) information sharing event on Friday 28th June 2019 attended by businesses and companies who are members of the Chamber.

UNDP Partnership and Entrepreneurship Specialist, Mr Hunjai Lee made an informative presentation on how sustainability reporting can promote private sector to adopt business practices that move communities toward inclusive sustainable development.

He highlighted that this kind of responsible engagement between the private sector and communities is also accordance with the country National Development Strategy (NDS).

Mr Lee said UNDP is currently working with private companies in the Solomon Islands to implement CSR activities.

One of them is SICCI member, Kokonut Pacific Solomon Islands (KPSI) who have their unique way of producing coconut oil, which is called Direct Micro Expelling (DME).

SICCI attends Pacific tripartite forum in PNG

Monday 29 July, Honiara – SICCI was part of a Solomon Islands delegation that attended the Pacific tripartite high-level forum on climate change and decent work last week from 24-26 July in Port Moresby, Papua New Guinea (PNG).

SICCI was represented by Board Member and Manager of local company Star Supplies, Ms Hilda Lamani at the forum.

Ms Lamani said the forum, co-organized by the International Labour Organization (ILO) and the PNG Ministry of Labour discussed climate action and the future of work in the Pacific, and how to ensure a smooth transition to an environmentally sustainable world of work.

Thirteen (13) labour ministers from ILO member states of the Pacific, including representatives of employers and workers, regional development partners and friends converged in Port Moresby over the three days to deliberate on these major issues of concern in the Pacific.

The Solomon Islands delegation at the forum included the Minister of Commerce, Industry, Labour and Immigration (MCILI), Honorable Clezy Rore and his Permanent Secretary Mr Riley Mesepitu (representing Government), National Secretary to the Solomon Islands Council of Trade Union, Mr Tony Kagovai (representing workers) and the Chamber of Commerce (SICCI) representing employers.

Ms Lamani said each party were separated into three different meetings to raise Solomon Islands' concerns, challenges and issues based on the following themes:

- Future of Work for Climate Resilience
- Labour Mobility in Pacific Island Countries
- Opportunities and challenges of digitalization for decent work.

Strata Titles on the agenda at SICCI roundtable

Monday 5 August, Honiara – Strata Titles was among topics discussed at a stakeholder's roundtable exploring options on land reform for the private sector hosted by SICCI on Wednesday 31st July 2019.

It is the first substantive effort by SICCI to pose private sector views on land reforms in the country.

Commissioner of Lands at the Ministry of Lands, Housing and Survey, Mr Allan McNeil made a presentation about the Strata Title legislation, its application process as well as taking questions from SICCI members and private sector representatives who gathered for the forum.

Mr McNeil confirmed that the Strata Titles Act and Regulations has commenced on 1 July 2019 and anyone can now apply for a strata subdivision.

Discussion on agriculture, land priorities with members

Monday 5 August, Honiara - SICCI in July this hosted stakeholders' roundtables on private sector priorities for agriculture and land reform.

The agriculture roundtable was held on Thursday 25th July 2019 attended by SICCI members in the agriculture sector and a land roundtable on Wednesday 31st July 2019.

This is part of SICCI's advocacy efforts to address the key impediments to economic growth maintaining that in order for businesses to grow, it is imperative that there is an enabling business environment that supports economic growth, encourage business growth and the creation of jobs for Solomon Islanders.

"The main aim behind hosting these roundtable forums is for SICCI members to identify areas of partnership with the Solomon Islands Government through its relevant ministries and for our members to bring up issues, challenges and recommendations to inform government policy efforts," SICCI Executive Officer, Mr Nelson Kere, said.

In the agriculture sector, SICCI members highlighted that Government must allocate necessary resources towards services that will allow for the sector to grow.

There is also a need to provide appropriate support for small holders who face a range of challenges regarding access to information, meeting market demands.

SICCI members also highlighted that there can be improved coordination between Government, development partners and private sector in the agriculture space.

During the land reform roundtable held on Wednesday 31 July 2019, Commissioner of Lands, Mr Allan McNeil made a presentation on the Strata Titles Act while National Recorder from the Ministry of Lands, Housing and Survey, Ms Mary Tegavota presented on Customary Land Registration.

Forum on infrastructure priorities

Thursday 18 July, Honiara – SICCI on Wednesday 17 July 2019 hosted a stakeholders' forum on the topic 'Infrastructure Priorities for Private Sector' attended by private sector representatives.

They were briefed by Solomon Islands Government officials and officers of the Australian High Commission in Solomon Islands.

SICCI Advocacy Officer, Mr John Ta'amora said the main objectives of hosting this forum was to inform the private sector on Government's current economic infrastructure development activities and for Government to receive feedback on what the private sector think should be development priorities that will contribute to economic growth.

"This forum enabled the Government and private sector to have starting point to identify areas for Public Private Partnership in developing economic infrastructure and transparent policy framework," he said. There were two main presentations during the forum after which private sector representatives were given time to ask questions, make comments and give recommendations.

Roy Mae, Under Secretary of the Ministry of National Planning and Development Coordination (MNPDC) presented on the Solomon Islands National Infrastructure Investment Plan (SINIIP) highlighting the status of economic infrastructure projects in the country and other major infrastructure projects that are in the pipeline beyond the year.

Andrew Schoeffel, Economic Councillor at the Australian High Commission in Honiara, provided an overview of Australia's current and planned infrastructure work in the Solomon Islands, including updates on the development of the Solomon Islands Infrastructure Program (SIIP) and the recently-announced Australian Infrastructure Financing Facility for the Pacific.

Call for review of Tarriff & Utility costs amidst increase of minimum wage

Wednesday 28 August, Honiara – The Solomon Islands Chamber of Commerce and Industry (SICCI), as the peak body representing private sector in the country, is calling for a reduction of tariff and utility costs following the one hundred percent increase of the country's legal minimum wage.

This includes a review to reduce electricity tariffs, port tariffs and in Information and Communications Technology (ICT).

SICCI believes that this will help support businesses with meeting the new increased costs and help foster confidence which is vital for continued investment and expansion plans.

"While Coral Sea Cable and Tina River Hydro projects are ongoing, we need to see some reductions in the interim until these two projects come online for the full cost saving benefits," a SICCI statement said.

With the increase in the legal minimum wage, SICCI reiterated that increasing PAYE thresholds will also ensure that a broader spectrum of the workers can take home more pay.

"Increasing the minimum wage impacts positively only on minimum wage earners'

"PAYE needs to be reviewed and the thresholds need to be increased so that employees can earn a decent living," SICCI Chair, Mr Jay Bartlett, said.

SICCI is also calling on the Government to stagger the implementation of the new minimum wage over a number of years, rather than a 100% increase to companies at immediate effect.

This is to give companies time to deal with a 100% increase in wages of employers on minimum wage and adjust operational budgets.

"Without a staggered approach, businesses are more likely to pass on the increased costs to their customers or more drastically, lay off staff or go through natural attrition where Without a staggered approach, businesses are more likely to pass on the increased costs to their customers or more drastically, lay off staff or go through natural attrition where workers scheduled for exit are not replaced. Companies could also cut back on extra staff benefits that may affect welfare of all its employees, not just the workers on minimum wage.

workers scheduled for exit are not replaced. Companies could also cut back on extra staff benefits that may affect welfare of all its employees, not just the workers on minimum wage," SICCI Chief Executive Officer (CEO), Ms Atenasi Ata, said.

"This increase affects too student apprentices who are attached to companies as part of their certificate courses. This group could be the first ones to be highlighted for budget implication, which leads to a bigger issue of quality attachment experiences which only big companies can provide. This affects our youth who want to enter the workforce valued as skilled workers."

Ms Ata notes in addition that SMEs account for 70% of SICCI's membership and should also warrant special thought.

"SMEs are important as they provide services and goods that reaches throughout the country and in some cases provide employment that spans the informal sector. SMEs are also those who provide first time work experience for young people during school holidays," said CEO Ata.

"Now they are faced with critical

decisions. A higher minimum wage rate will mean an increase in the cost of their services. This can drive customers away. We heard from security service providers who asked that the increase should be in the range of \$5.00 to \$6.50 per hour. Now they may seriously consider downsizing or shutting down if they are not able to break-even.

"One thing that is missing from the discussions too is how the year has been for businesses with the NGE and the Voter Registration prior to that with high worker mobility experienced. Straight after that Honiara businesses went through a week during the election of the PM where they were either in shut-down mode or operated on skeletal staffing. It has been a tough time for businesses," she said.

Following the announcement, on 12th August, a SICCI delegation presented a case for a staggered approach to help soften the impact on companies.

This was approved in-principle by the Minister for Commerce, stating that it would be a case-by-case approach and requiring provision of financial records of the company concerned.

'Home Blo Iumi' seeks to pave pathway to entrepreneurship

"Building a culture of entrepreneurship amongst the nation's youth is vital in changing the mindset from being job seekers to job creators," he said.

Addressing youth unemployment is a priority for the Solomon Islands Government (SIG) and innovative entrepreneurship programs like Home Blo lumi can offer a significant step forward in finding a solution.

According to YECSI's Membership and Communications Officer, Ms Irish Melaume, there are only fifty (50) spaces available and to be selected, interested participants were required to enter a business challenge and win a place on Home Blo Iumi.

The Home Blo lumi Program is purposely for aspiring entrepreneurs ranging from ages 16-24 and is open to students currently enrolled in forms 5, 6, and 7 and those that have left school in the last years.

The Home Blo Iumi Program itself will be held September 30th – October 4th in the term 3 school holidays.




