COMMENTARY

International Arrivals

Total arrivals for the Second quarter 2019 were 13,747. This is an increase of 16.0% compared to the previous quarter (1st quarter 2019). Compared to the same quarter a year ago, a decrease of 6.2% was recorded.

Visitors made up 51% of arrivals for Second quarter 2019. This was followed by Returning residents with 48% of arrivals and the remaining 1% were Intending residents.

Visitor arrivals for the second quarter increasse by 17.4% to 7,063 visitors, compared to the first quarter 2019 figure of 6,019 visitors. There was a 0.6% increase in visitors arrivals from second quarter 2018 to second quarter 2019.

Chart 1 shows that the returning and visitors categories make up the largest proportions of all arrivals while the intending resident category makes up the lesser share this quarter. This information comes from table 1: Total Arrivals to the Solomon Islands by Purpose of Travel by Sex: 2nd Quarter 2015 to 2nd Quarter 2019.




Chart 1: Arrivals By Category 2nd Quarter 2019

Visitors by Country of Residence


Arrivals by country of residence for the second quarter 2019 showed that Australians (40.4%) remain the largest group of visitors to the Solomon Islands. There was a 25.2% increase to 2,854 in Australian visitors compared to the first quarter of 2019 figure 2,279.

The next largest group of visitors were from Other Asia (12.6%), followed by United States of America (7.9%), New Zealand (7.2%), Fiji (5.3%), Papua New Guinea (5.0%), and China (4.1%). Table 2 shows detailed information on Visitor Arrivals to the Solomon Islands by Country of Residence: 1st Quarter 2016 to 2nd Quarter 2019.

Visitors by Month

Visitor arrivals by month showed that June recorded the highest number of arrivals in the second quarter of 2019 with 2,523 visitors. This was followed by month of May with a total of 2,434 visitors and April the least with 2,106 visitors. 
Chart 2: Visitor Arrivals by Month, January 2017 - June 2019



Tourists

Second quarter 2019 recorded a total of 2,577 tourists and they spent an average of 14.8 days in the country. Australian residents still made up the highest proportion of tourists (43.3%) for the quarter and stayed in the country for an average of 12 days. Residents from the United States of America made up the next largest group of tourists (11.8%), followed by Other Asia (8.2%), Other Pacific (6.1%) and New Zealand (4.9%) Refer to Table 4: Visitors to the Solomon Islands Classified as Tourists by Country of Residence and Average Length of Stay (in days): 1st Quarter 2017 to 2nd Quarter 2019.

Visitors by Purpose of Visit

The most common reason for visitors visiting the Solomon Islands during the quarter was for Holiday and Vacation (32.6%). This was followed by Business and Conference (25.5%), visiting for Other Reasons (24.5%), Visiting friends and relatives (13.5%) and Transit & Stop over (3.9%). 


Chart 4: Percentage of Visitor Arrivals to the Solomon Islands by Purpose of Visit, 2nd Quarter 2019

Visitors by Age Group

The distribution of visitor arrivals by broad age groups for second quarter 2019 showed that 74.6% of Visitors were in the 25 years to 64 years age range. The youngest age group, 0 -24 years, represented 12.8% of the arrivals while the oldest age group, 65 years and over made up 9.3% of total visitor arrivals. The remaining 3.3% were visitors who did not state their age. Male visitors represented more than half of the total visitors arrivals (66.9%) and female visitors made up 33.1% of arrivals this quarter. Visitors by Occupation

Visitor by Occupation showed that the "Other occupation" category mades up the largest percentage of occupations (36.4%) during the quarter. This was followed by "Professional and Technical" (32.2%), Administration and managerial position (10.5%), No work (10%), and Production and Related Work (3.4%). Visitor by Carrier

The most popular carriers during the quarter were Solomon Airlines who carried (50.1%) of total visitors, followed by Air Niugini (21.8%) and Virgin Australia (16.6%).

Visitor Arrivals to Munda

Arrivals by country of residence to Munda for second quarter 2019 showed that Australians (81.1%) recorded the largest group of Visitors. This was followed by visitors from United States of America with 7.7 % of the arrivals. ABOUT THE BULLETIN

Concepts and Definitions

Persons entering Solomon Islands classify themselves into three (3) categories; returning resident, intending resident, and visitor. The concepts and definitions of the various categories are as follows:

(i) Returning residents

- Solomon Islanders and non-Solomon Islanders who have left the country and are returning to continue their residence.
- Non Solomon Islanders includes resident permit holders and Diplomatic officials, and their immediate family members. This may also includes legal or official arrangements that fall outside of the above.

(ii) Intending residents

Non-Solomon Islander who wish to take up residence in Solomon Islands.

(iii) Visitors

- Any traveler who is not a Solomon Islander and their stay and intention of stay should last no more than 12 months¹, in the country and does not have a permanent/contract employment.
- Tourist
 - Visitors who further classify themselves stating their visit are purposely for 'holiday and vacation'. This exclude, tourist arrivals by cruise ships.
 - Wife accompanying husband on business purpose is a private tourist unless also working.
 - World Tourism Organization WTO definition of Tourism:
 It comprises the activities of persons travelling to and staying in places outside their usual environment for not more than one consecutive year for leisure, business and other purposes not related to the exercise of an activity remunerated from within the place visited.

(iv) Markets

Country of Usual Residence is referred to as 'markets' by the Solomon Islands Visitors Bureau

Note: For Quarter 1 2018 onwards the National Statistics Office will be using the new set of definitions provided by the South Pacific Tourism Organization (SPTO).
