




# 1 . A n I n t r o d u c t i o n

- **Facilitates business names, incorporate companies, register charitable trusts & monitors secured transactions online.**






# BACKGROUND FOR THE INCREASE OF FEES



Application to restore registration of business name	225







The Principal Regulation is amended by substituting “SCHEDULE PRESCRIBED FEES” with the following:

## “SCHEDULE - PRESCRIBED FEES

Other fees	Fee (SBD\$)
Certification of document (section 190)	150
Copy of document that is part of register	5 per page (in addition to any fee for certification under section 190)
<b>Failure to deliver</b> a companies related document to the Registrar but providing such a document	150
Within 25 working days after the time prescribed by the Companies Act 2009	
Example: Failure to deliver an annual return	
<b>Failure to deliver</b> a companies related document to the Registrar within 25 working days after the time prescribed by the Companies Act 2009	480
Example: Failure to deliver an annual return



Application for Annual Survey (Due to submit every 31 <sup>st</sup> March)	300




